[Information about measurements]

- \*\*1 : In case that the instrument indicates minus hydrogen density, "0%" is recorded. (Because there's the possibility of minus indication due to the instrumental precision when hydrogen density is very low.)

  The hydrogen concentration in the PCV gas control system is provided.
- \*\*2: In case that the instrument reading is below measurable limit, "ND" is recorded. The radioactivity density (Xe135) in the PCV gas control system is provided.
- 3: Flow rate values are adjusted according to the temperature and the pressure under usage conditions.
- \*4: Nitrogen gas injection is under suspension.
- \$\times 5\$: The reactor water injection by the condensate storage tank reactor water injection line is being confirmed.
- \*\*6 : Regarding the status of water injection to the reactor as of 5:00 AM and as of 11:00 AM on July 4, the actual flowing amount of the feed water system and the core spray system was prove to be different from the pretended flowing amount due to the error found at water injection line. There is no change of the total water injection amount.
