- *11: In case that the instrument indicates minus hydrogen density, "0%" is recorded. (Because there's the possibility of minus indication due to the instrumental precision when hydrogen density is very low.)
- The hydrogen concentration in the PCV gas control system is provided. **2 : In case that the instrument reading is below measurable limit, "ND" is recorded.
- The radioactivity density (Xe135) in the PCV gas control system is provided. X3: Flow rate values are adjusted according to the temperature and the pressure under usage conditions.
