<sup>\*\*1 :</sup> In case that the instrument indicates minus hydrogen density. "O%" is recorded. (Because there's the possibility of minus indication due to the instrumental precision when hydrogen density is very low.)

The hydrogen concentration in the PCV gas control system is provided.

<sup>\*\*2:</sup> In case that the instrument reading is below measurable limit, "ND" is recorded. The radioactivity density (Xe135) in the PCV gas control system is provided.

<sup>\*3:</sup> Flow rate values are adjusted according to the temperature and the pressure under usage conditions.

<sup>\*\*5 :</sup> Alternative cooling equipment of the Fuel Pool of Unit 2 is stopped. Therefore, Temperature in the spent fuel pool and FPC skimmer surge tank level of Unit 2 show close data. The expected temperature increase at the SFP water is around 0.125°C/h.
