

### **Documents eligible people need to send**

1. Documents those who were in particular situations such as requiring long-term care need to send

(1) Those to whom the above mentioned status was applicable as of November 30, 2013

i. Please send TEPCO a copy of a certification document that was valid on November 30, 2013 (an insured person's certificate for Long-term Care Insurance, a physical disability certificate, a mental disability certificate, a rehabilitation certificate, or any other certificate that can confirm the situation such as requiring long-term care).

ii. If two or more of the situations to be compensated are applicable to you for a certain month, please send TEPCO only one certification document that corresponds to the highest of all the amounts set for your situations when sending the document as described in (1)- i.

iii. If you were certified as requiring long-time care at a higher nursing care level for a period before November 30, 2013, or for a period preceding the period printed on the certification document you are going to send to TEPCO, please send TEPCO a certification document that can prove the period and the condition with the higher nursing care level, in addition to the certificate as described in (1)-i and (1)-ii.

iv. If you have no certification document as described in (1)-i and (1)-ii due to loss or other reason, or if you have no certification document certifying the condition as described in (iii), please contact TEPCO on 0120-926-404 (TEPCO Fukushima Nuclear Compensation Office) so that the company can confirm the necessary information.

(2) Those to whom 1-(1) is not applicable, but who were in particular situations such as requiring long-term care from March 11, 2011 to November 29, 2013

i. Please send TEPCO a copy of a certification document that was valid on

the date closest to November 30, 2013 (an insured person's certificate for Long-term Care Insurance, a physical disability certificate, a mental disability certificate, a rehabilitation certificate, or any other certificate that can confirm the situation such as requiring long-term care).

ii. If two or more of the situations to be compensated are applicable to you for a certain month, please send TEPCO only one certification document that corresponds to the highest of all the amounts set for your situations when sending the document as described in (2)- i.

iii. If you were certified as requiring long-time care at a higher nursing care level for a period before November 30, 2013, or for a period preceding the period printed on the certificate you are going to send to TEPCO, please send TEPCO a certification document that can prove the period and the condition with the higher nursing care level, in addition to the certificate as described in (2)-i and (2)-ii.

iv. If you have no document as described in (2)-i and (2)-ii due to recovery of health, death, loss or any other reason, or if you have no certification document certifying the condition with the higher nursing care level as described in (iii), please contact TEPCO on 0120-926-404 (TEPCO Fukushima Nuclear Compensation Office) so that the company can confirm the necessary information.

2. Documents those who cared for a person requiring constant nursing care need to send

There are no required documents, since TEPCO will confirm the details of each case based on the documents as described in "1. Documents those who were in particular situations such as requiring long-term care need to send".
